August events

-Outerbike had 550 participants. Much bigger than Outerbike spring or Whistler ever got. Everyone was excited. Coming back the same weekend next August. Walton Family Foundation showed up to check out the event. They had in their head that we were the center for trails and mountain biking. They want to do the same in Bentonville. Their reasoning is due to the following: Health, make the area more attractive to companies for relocation, and tourism. It affirmed to us that the TA was on the right track.

-Beach Bash-130 paid people showed up. We struggled just because we didn't have enough beach due to the water level. Shane with Shaboomee pretty much made the event. Good vibe, fun atmosphere. We are not a National Parks Vendor so we cannot sell tickets day of. We would like to do another year running it as the TA then try and hand it off. First year had about 3-5 out of towners, this year we had around 60 out of towners. We have tried for years to activate the Blue Mesa and this is as close as we have come.

Winter flight focus

Denver-January and February are both strong currently.

Lodging tax issues

County and Municipalities are not coming together correctly. The County is missing about 10% of its lodging tax revenues. All the municipalities are saying that they are up. The localities are aggressively chasing the tax money. The County/State level is not on top of it. Gunnison County purchased STR helper to help track some of this which should help the State gather the data. This is 100-120k problem for us, so we have gone to the county to get the numbers in line.

2018 budget
